The petition now has over 2000 signatures. Warm Springs Alliance this week will send a letter to each member of City Council and the mayor with Executive Summary of the plan. Warm Springs Alliance has the beginning of business plan — money will be the subject now. Suggestions from board to take back to Warm Springs Alliance.
