Welcome and Review of September and October minutes- Laura Arellano
Motion the approve- Mike Mitchell Second- Kimberly Wiley, unanimously approved.

District 3 City Council- Chris Wharton

- Salt Lake City's bid for the 2030 Winter Olympics is on track. Only American competitor is Denver. Other competitor is Milan, Italy. SLC has the advantage of having all the necessary venues and having maintained them so that the cost of improvements would be less than \$i million. IOC may need a venue for the 2026 Olympics and SLC could be considered for that.
- SLC will be hosting a UN conference in August 2019 at the Salt Palace.
- City Council is working on a Community Redevelopment Area on State Street
- Derek Kitchen, current member of city council, was elected to the Utah State Senate. He will resign from the council on the same day he is sworn in as a senator. The city will then solicit people interested in assuming his seat on the council.
- Council is discussing increasing their compensation. Council members are doing much more work than they did when the present system was created in the 1980's. There will be a public hearing on this issue at the next council meeting.

Salt Lake City School District Board- Katherine Kennedy

- Thanked voters for their support in recent election.
- The School Board recently voted to keep West HS "open" (students from anywhere in the district as well as outside the district can enroll there.) All Salt Lake City schools are open in this way.
- The School Board has made literacy and social-emotional wellness its consensus goals.
- The District will give bonuses of \$250-300 to every contract employee this year.

SLCPD- Detective Alen Gibic

- Three weeks ago, SLCPD officers, with support of the SL County DA's office and Amazon, Inc., mounted a sting to catch thieves stealing packages from porches. No one was caught. Police estimated their chance of catching someone in the act of stealing a package as one in 2300.
- Recommends that residents have secure place on their porch, such as a bin or locker, for deliveries. A package drop box can be installed at homes.
- Det. Gibic has gun locks available at no charge.
- Residents should not leave their cars unattended while warming up in their driveway. Thefts of vehicles left this way are common.
- SLCPD caught two thieves who stole two cars from a garage in the Avenues.
- Question from G. Stutzenberger- How does the SLCPD grow to handle population growth? Det. Gibic- SLCPD is constantly hiring. Hard to find qualified candidates. Tries to enlarge force to keep up with population growth.

- SLC is filing an amicus brief in support of the lawsuit against the Trump administration for shrinking the Bears Ears National Monument
