Secretary's Review of January Minutes: Andrea Ashbridge

Council Chair Updates

IRS/501c3 Status: Michael Measom found them and some emails regarding them. Laura talked to IRS. It has been too long, and we have to start over.

Discussion: The process is easier and can be done online, and the fee is less. We won't need a CPA or lawyer. Fee is only about \$250 now.

Motion: Polly moves that Laura proceeds with new application and spend the money necessary in neighborhood of \$300 and to alert the board if the price is more than that.

CHNC Bylaws:

Michael got in touch with Richard Starley and Laura reviewed, we have the most current bylaws: dated with November date. Very few differences between the two. Newest ones do say we are a 501c3. The Bylaws we have online (CHNC website) appear to be correct. Dean Larsen will look for an even more recent version.

Community-based Organization Renewal:

We have updated Community-based Organization status with City, and the Bylaws on file with them are the ones we have now, so if we find even newer bylaws we will update City.

Committee Updates

Advocacy Committee

Warm Springs Park Building: David Scheer

August 2016, Salt Lake City issued RFP for Warm Springs Park building. David is on the committee that reviewed 2 proposals: *one for an office building with partial second floor over pool, one to use as base for multi family housing. Multi family housing plan comes from Woodbury, leaders in the field. Their proposal however was not well received by the committee because it involved destroying space where main pool is, and would result in loss of historic tax credits. Also unlikely to pass Historic Preservation Council. This week, Dan Ripp, City Real Estate Official, sent Woodbury an email to reconsider their design.* Neither proposal was adopted. We await revised design from Woodbury. No timeline set.

Discussion regarding CHNC's role in the process. The announcement was made through normal channels. Laura assigns to the CHNC Advocacy Committee looks further into it, to see what we can/want to do, bring it back to us and we can put it on agenda.

Follow up Action: David will wait for results, will keep an eye on the issue, and will call an Advocacy Committee meeting if necessary.

ADU Ordinance: David Scheer

Capitol Hill is not in ADU Ordinance area on old zoning. In new zoning, we are included.

Discussion: Where ADU is allowed in the city and Setbacks. Number of permits per year and Parking.

Follow up Action: Laura assigns Advocacy Committee to meet on it and put on agenda in future. Dean Larsen "seconds"/supports.

Bishop Place Demolition: Bob Springmeyer

Bob Springmeyer is working for the property owner and would like to present at February Regular meeting (February 15th). The following evening, February 16th, there will be a public input meeting regarding the Bishop Place demolition. Property owners and residents within 300 feet have been sent notice of the public input meeting. Eleven parcels set for demolition with the plan is to build new single family homes.

Discussion. Laura will add Bob Springmeyer to next Regular meeting (February 15th) agenda to give an overview. Polly suggests we all go see the property and then we vote.

Safer Cycling: John Mitchell

One big question is how to get from 300 West to Rose Park. There is a proposal for a bike lane on 600 North. Assigned to CHNC Advocacy Committee.

Garage on Beck parking Issue: Jack Winward

The Garage on Beck is suffering because City is ticketing people for parking on the street, in the bike lane.

Discussion: We are requested to write letter to City, asking for moratorium on parking tickets.

Follow up Action: Jack will draft the letter. Marsha Merrill from The Garage will also be on agenda for Regular meeting in February to address the neighborhood.

Loma Lane issue: Vicky Collard

Neighbors want Loma Lane made its full width. Assigned to CHNC Advocacy Committee.

Columbus Street issue: Georg Stutzenberger

Assigned to CHNC Advocacy Committee.

Map Update, Blue Light Project: Georg Stutzenberger

Jack Winward will join the effort.

Engagement Committee: Jack Winward

The Engagement Committee is proceeding with July Fourth Pancake Breakfast and Jam Fest. We already have money and a good plan. Request to plan a neighborhood Christmas event.

Communication Committee: Laura Arellano

Committee news: Pen in Andrea Ashbridge. Jeremy Harris from the CHNC neighborhood will join us. Laura will assign a Communications Committee chair.
